

Terms & Conditions

1. Promoter and Prize Supplier

- 1.1 The promoter is Corporate Prepaid Cards Pty Ltd (ABN 25 092 828 772), located at Unit 1, 5 Rosebery Place, Balmain NSW 2041 ("the Promoter").
- 1.2 The prize supplier is Mastercard Asia/Pacific (Australia) Pty Ltd (ABN 95 108 603 345) ("Mastercard"). Mastercard is the supplier of the prizes only and is not the promoter of, nor responsible for the conduct of this Promotion.

2. Promotion

- 2.1 The promotion, titled **Corporate Prepaid Cards Australian Open 2025 Competition** ("Promotion"), is a trade promotion conducted by the Promoter for the purpose of incentivising the placement of orders with Corporate Prepaid Cards.
- 2.2 The promotion commences on 20th October 2025 and closes at 11:59pm AEDT on 21st November 2025 ("Promotion Period"). Entries received outside the Promotion Period will not be accepted.

3. Eligibility

- 3.1 Entry is open to businesses operating in Australia who, during the Promotion Period, place an order for Corporate Prepaid Cards ("Eligible Entrants").
- 3.2 An order may include any order placed by a business during the Promotion Period.
- 3.3 The promotion is not open to:
- a) employees of the Promoter, Mastercard, or any of their related bodies corporate, agencies, or immediate family members; or
- b) individuals entering in a personal capacity (entries must be made on behalf of a business).
- c) any person under the age of 18

4. How to Enter

- 4.1 Each qualifying order placed during the Promotion Period will automatically generate one (1) entry into the prize draw.
- 4.2 Multiple entries are permitted, with one (1) entry awarded per qualifying order.
- 4.3 Only entries that comply with these Terms and Conditions are valid.

5. Prizes

5.1 There is one (1) Major Prize and four (4) Minor Prizes to be won.

Major Prize

5.2 The first valid entry drawn will win a Mastercard Priceless Package to the Australian Open 2026 for two (2) adults ("Major Prize"). Each Major Prize includes:

- Two (2) return Economy airfares from the winner's nearest Australian capital city to Melbourne, Australia (only provided if the winner does not reside in VIC);
- Two (2) nights' twin-share 5-star (or equivalent) accommodation in Melbourne;
- Two (2) Rod Laver Arena, Women's Semi-Final tickets to the Australian Open on Thursday, 29 January 2026;
- Two (2) passes to Champions Rooftop, including live cooking by Peter Gilmore, food & beverages, live entertainment, and a visit from a tennis legend on the day.
- 5.3 The total maximum value of the Major Prize is up to AUD \$20,000. The final value will depend on actual travel and accommodation costs at the time of booking.
- 5.4 The Major Prize is subject to the following travel and event conditions:
 - Travel must coincide with the Australian Open 2026 event dates as determined by the Promoter.
 - If the winner is unavailable or unwilling to travel on the required dates, the prize (or relevant components) will be forfeited and cannot be exchanged for cash or an alternative in lieu.
 - The winner and their companion must depart from and return to the same departure point and travel together.
 - Prize elements are subject to booking and flight availability.
 - Subject to the terms and conditions of the participating prize provider(s), if for any reason the winner does not, once the prize has been booked, take the prize (or an element of the prize) at the time stipulated, then the prize (or that element of the prize) will be forfeited and will not be redeemable for cash.
 - Frequent flyer points will not be awarded and do not form part of the prize.

- During the entire duration of the prize, a nominated parent/guardian must accompany any person under 18 years of age.

- All Australian Open tickets are subject to the <u>AO26 Ticket Conditions of Sale and Entry</u>.
- All AO hospitality experiences are subject to the <u>AO26 Hospitality Conditions</u>.
- Tennis Australia may photograph or record winners during the prize event, and such media may be used in promotional materials without further notice or compensation.
- Winners and companions must comply with AO venue rules and may be removed for inappropriate behaviour, including intoxication.

Minor Prizes

5.5 The next four (4) valid entries drawn will each win one (1) **Mastercard Prepaid Gift Card valued at \$250** ("Minor Prize").

- 5.7 The total prize pool is valued at up to AUD \$21,000.

5.8 Prize Fulfilment

The Promoter will nominate and contact the winner(s). For the Major Prize, the winner's

details will be provided to Mastercard (the prize supplier) solely for the purpose of prize fulfilment. Mastercard will liaise directly with the Nominated Representative of the Winning Entrant to arrange flights, accommodation, hospitality experiences, and event ticketing. For the Minor Prizes, Mastercard will also distribute the \$250 Mastercard Gift Cards directly to the winners. By accepting a prize, the Winning Entrant and their Nominated Representative consent to the Promoter sharing their details with Mastercard for this purpose.

6. Prize Allocation

- 6.1 The Major Prize and Minor Prizes will be awarded to the winning business (the "Winning Entrant").
- 6.2 The Winning Entrant may nominate one (1) individual representative (employee, director, or authorised officer of the business), aged 18 years or older, to accept and utilise the prize on the business's behalf ("Nominated Representative").
- 6.3 It is the responsibility of the Winning Entrant to ensure that their Nominated Representative is legally entitled and authorised to accept the prize.
- 6.4 The Promoter accepts no responsibility for how the prize is distributed or used within the Winning Entrant's organisation once it has been awarded.
- 6.5 Any tax implications (including Fringe Benefits Tax, if applicable) arising from the award or use of the prize are the responsibility of the Winning Entrant.

7. Draw and Notification

- 7.1 The winner will be selected electronically at Corporate Prepaid Card Head Office at Unit 1, 5 Rosebery Place, Balmain NSW 2041 at 1pm AEDT on 25 November 2025.
- 7.2 The first valid entry drawn will receive the Major Prize. The next four (4) valid entries drawn will each receive one (1) Minor Prize.
- 7.3 Winners will be notified by phone and email within two (2) business days of the draw and details will be published on Corporate Prepaid Cards website and marketing communications for a minimum of 28 days.
- 7.4 If a winner cannot be contacted within fourteen (14) days of the draw, or does not claim their prize within that time, the Promoter will conduct a redraw at the same place as the original draw at 1:00pm AEDT on 9 December 2025. Any redraw winner will be notified by phone and email within two (2) business days and published on the Corporate Prepaid Cards website and marketing communications for a minimum of 28 days.

7.5 If a winner from the redraw cannot be contacted or does not claim their prize within fourteen (14) days of the redraw, the prize will be forfeited and no further redraw will occur. In such circumstances, the Promoter's decision is final, and no correspondence will be entered into.

8. Verification

8.1 The Promoter reserves the right to verify the identity and eligibility of all entrants, the validity of entries, and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions.

9. Liability

- 9.1 The Promoter is not responsible for any loss, damage, or injury suffered by the Winning Entrant or Nominated Representative in connection with the promotion or the use of the Prize, except for liability which cannot be excluded by law.
- 9.2 The Promoter is not responsible for any additional costs incurred by the Winning Entrant or Nominated Representative in relation to the Prize.

10. General

- 10.1 The Prizes are not transferable, exchangeable, or redeemable for cash.
- 10.2 If the Major Prize or Minor Prizes (or any part of them) become unavailable, the Promoter reserves the right to substitute with a prize of equal or greater value.
- 10.3 The Promoter reserves the right to vary, suspend, or cancel the promotion at any time without notice, subject to regulatory approval.
- 10.4 The Promoter is responsible for conducting and administering the Promotion only. Mastercard is the supplier of the prizes and is not the promoter, nor responsible for the conduct of the Promotion. For the Major Prize, Mastercard will manage all communications directly with the winner's Nominated Representative in relation to the fulfilment and organisation of the prize.
